The **Kentucky Board of Licensure for Long-Term Care Administrators** will meet on **July 1, 2021**, at **10:00am EST** by live audio or live video teleconference pursuant to the Kentucky Open Meetings Act, KRS 61.800, *et seq.*, Senate Bill 150, and Executive Order 2020-243 in response to the COVID-19 state of emergency.
